Rogue Valley Transportation District (RVTD) is seeking information from firms for Non-Emergent Medical Transportation (NEMT), ADA Paratransit and Micro Transit software solutions. This Request for Information (RFI) may be used as a preliminary step to help RVTD develop a formal Request for Proposals to solicit additional participation in replacing aging software services.

BACKGROUND: RVTD is a public transportation district located in Jackson County, City of Medford, Oregon. Through their TransLink Brokerage, RVTD manages multiple programs, grants and contracts designed to improve transportation services for older adults, individuals with disabilities, low-income populations and occasionally services to the public.

The TransLink Brokerage has been providing services for ADA Paratransit and Oregon Medicaid Non-Emergent Medical Transportation (NEMT) locally and throughout Oregon. Currently, the TransLink Medicaid Brokerage manages transportation services through several NEMT transportation contracts including ones directly with the Oregon Health Authority (OHA) and Coordinated Care Organizations (CCO). TransLink manages all aspects of NEMT trip brokering including meal, mile and lodging reimbursements, provider provided transports, common carrier trips, public transportation options, billing (EDI), eligibility verification and flex services to name a few. Services are primarily provided through contracts with NEMT providers. RVTD would like to see that increased significantly so more district operated vehicles are used for local NEMT services.

Our Valley Lift program is a service for individuals with disabilities unable to utilize fixed route bus services and provides transportation above and beyond the required ADA guidelines. The service mirrors fixed route service days and hours of operation.

Both our Medicaid and ADA Paratransit programs are managed through separate, siloed software solutions which eliminate our ability to easily coordinate trips across programs. Service is provided in-house with RVTD owned vehicles.

RVTD also operates the Rogue Valley Connector (RVC) service, connecting rural areas of the county with fixed route buses and paratransit service. The interest is to identify a micro transit solution that can not only work for the RVC service but can also be leveraged to improve

services to both our ADA and Medicaid programs as well. RVTD is very interested in having a micro transit solution for this project.

- Medicaid Vehicles 260+

PURPOSE: Replace aging software which does not allow the brokerage to efficiently coordinate services, maintain cost efficiencies or reduce administrative overhead.

OBJECTIVES: Replace existing software with a single software platform that improves coordination, reduces costs, and allows the brokerage to maintain and expand their existing services and programs without the need for significant changes. Software should connect providers, passengers, and the brokerage together through apps and services to improve overall outcomes of the services provided through the brokerage. Replace complicated and often frustrating software configurations and reporting features that are simply unusable and uninformative; reporting should be easy to configure, not require a DBA to pull basic data and improve the brokerages knowledge of services to passengers. Mapping should be clean and intuitive making the creation and editing of map zones and boundaries easy and flexible. New system preferably would be cloud based and accessible from any internet-based computer or device. It is RVTD's intention to use responses to this RFI to identify software vendors in their future RFP solicitation. RVTD anticipates contracting with a software vendor within the next 6-10 months.
